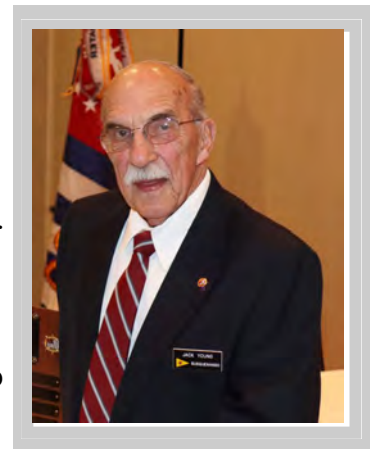

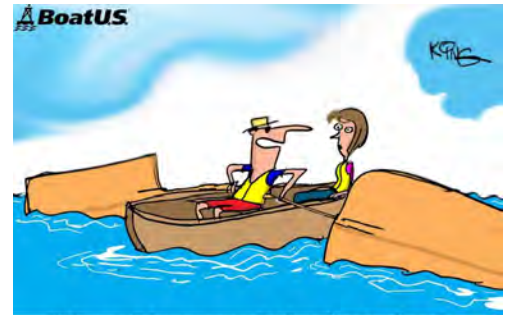


BOSCOV'S FRIENDS HELPING FRIENDS
