Mariner's Have Their Own Language

I suppose every mariner has had fun telling landlubbers and people new to boating that, once it comes aboard a boat, 'rope' needs to be called 'line,'" says Rocky Jones, who joined the U.S. Navy in 1946, and U.S. Coast Guard Auxiliary in 1988. Over the years, Rocky finally decided that this nomenclature problem wasn't so funny anymore, that a better explanation was needed, and that he was the man to give it. NEW MEMBER BENEFIT - Divers Alert Network (DAN)

At the recent National Governing Board Meeting an MOU was signed with *DAN Boating* making all USPS members eligible for emergency medical travel coverage at only \$25.00 per household. Effective 8 October, 2019, all members will automatically be covered at no cost to the member. At next dues renewal, there will be a \$25.00 charge attached. If you want to continue the *DAN Boating* coverage, pay that fee along with your dues. Delete the charge if you choose not to remain in the program.

Dan DeWitt, a past SSPS member, was in a situation where he needed to use this insurance and a testimonial from him on the value of this coverage follows:

"On a recent trip, about half way to the destination, my chronic indigestion condition appeared to reoccur. During the second night at the motel breathing in a prone position became difficult and sleep impossible. My spouse, Donna, refused to go further without a more thorough examination. Regional Florence, SC hospital examination room scans indicated a blown-out aortic valve that required immediate repair (for the third time). Due to the complexity of the procedure it was deemed necessary to find a more experienced hospital and staff. Because of very inclement weather air flight was considered too risky and a four hour ambulance ride the only possible alternative.

Donna, while worrying in the waiting room of the hospital, skimmed through her hand bag and noticed the documents from *Divers Alert Network (DAN)*. Truthfully, we had joined the *DAN* system just weeks earlier after hearing about it from a boating acquaintance. Donna noticed that there were a couple of caveats associated with their services (no longer required). Completing those, from that point onward *DAN* handled the evacuation. They took the contact information for the hospital, got all the particulars and got me to Duke University Hospital and into surgery.

In my mind, the best testimonial for *DAN* membership came when their representative called Donna the next day to check on how I was doing. She was alone in a strange city with a spouse in need of complicated cardiac treatment. That small gesture on *DAN*'s part was really no small gesture at all. I think it gave Donna some much needed hope.

We've been *DAN* members ever since. I heartily recommend and endorse their products. Please look at their web site <u>https://www.diversalertnetwork.org</u> you'll find there are several levels of insurance protection available depending on your anticipated exposure to risk. And, it does not have to be water related. Skiing at Vail would be covered.

SSPS members have an opportunity to protect themselves and their families should they experience an emergency that requires medical evacuation. Additionally, *DAN*'s experience in handling medical emergencies is invaluable.

DAN has contacts in most all areas of the world. The relationships they have established in the diving community globally allows them to determine the best way to provide assistance. The person you speak to when you call to get help will be able to provide invaluable information about not only what is needed, but where to get the service and how to get there.

Your one call gets the process in motion and *DAN* takes over from there. Please consider this opportunity." This new member benefit is worth looking into for your peace of mind while traveling.

All Power Boat Operators in NewYork Will Need Safety Course by 2022



Brianna's Law

The legislation, called Brianna's Law (S.5685/A.4853.A), was signed into law Tuesday by Gov. Andrew Cuomo and goes into effect Jan. 1, 2020. The law will be phased in over five years. The legislation is named after Brianna Lieneck, an 11-year-old girl killed in a boating accident in Long Island's Great South Bay in 2005. Since then, the girl's mother, Gina Lieneck of Deer Park, has lobbied law-makers to pass a boater safety course bill.

Currently, state law only required those born after May 1, 1996, to complete a boater safety course in order to drive a motor boat. The new law expands that requirement. Under the 5-year, phase-in plan, all motor boat operators born on or after Jan. 1, 1993 must complete a safety course to operate a motor boat beginning in 2020.

Those born after Jan. 1, 1988 must complete a safety course beginning in 2022. Those born on or after Jan. 1, 1983 must complete a safety course beginning in 2023. Those born on or after Jan. 1, 1978 must complete a safety course beginning in 2024.

The requirement would extend to all motor boat operators beginning in 2025, regardless of age. Failure to comply could result in a fine of between \$100 and \$250. The Office of Parks, Recreation and Historic Preservation, which administers the law, estimates that there are nearly one million boaters who will have to take the safety courses before the end of the phase-in on Jan. 1, 2025.

Governor Cuomo also directed State Parks to launch a boating safety promotional campaign to make sure boaters are aware of the new law and boater safety in general. The required safety course would result in the issuance of a boater safety course certificate and would provide training in such things as boat handling, use of navigational instruments and flotation devices, as well as state laws concerning boating operation and safety.

Those who've previously taken a boating safety course and don't have the certificate won't have to take a new course. A new one can be obtained through the New York State Parks website at a cost of \$10. For more on this, see the Parks website.

Under current law, a canoe or small rowboat with an electric motor is classified as a motorized craft and must be registered as such. It's not clear at this point if operators of those crafts will be required to take a boating safety course. The state commissioner of Parks will have the discretion of determining what kinds of vessels will be covered by the requirement.

This article, extracted from various web site information, submitted by Commander Mary Kucharek, raises many questions which will require both local and USPS National investigation.
